



## **RISK MANAGEMENT SUMMARY**

### **INTRODUCTION**

The following is a risk management summary for Lockerbrook Residential Education Centre. The purpose of this summary is to satisfy clients that our risk analysis and management systems are robust and that appropriate arrangements are in place to ensure the safety of clients and visitors.

### **THE RESPONSIBILITY OF GROUPS AND LOCKERBROOK RESIDENTIAL EDUCATION CENTRE**

Visiting groups are reminded that whilst Lockerbrook does take care to ensure that the site, buildings and accommodation are safe and fit for purpose, groups are responsible for the safety of their participants during their stay with us.

Where a group is running its own programme, responsibility for risk assessment, risk management, group safety and first aid cover rest with the group and its leaders. We encourage all group leaders to familiarize themselves with our Codes of Practice and Activity Risk Assessments.

## **SAFEGUARDING CHILDREN AND YOUNG PEOPLE**

All visiting groups are expected to have an appropriate Safeguarding (Child Protection) Policy and to follow that policy throughout their visit.

Lockerbrook, as part of Woodcraft Folk, has a comprehensive Safeguarding Policy and we seek to ensure the safety of children staying or working with us. This policy includes requirements to check the suitability of staff that have access to young people and where there are statutory requirements (e.g. Disclosure and Barring Service/Scottish Criminal Records Office, etc) this policy specifies that checks are carried out.

Our policy is consistent with current good practice in this area and scrutiny forms a routine part of our recruitment procedures. A copy of our Safeguarding Policy is available on request and on our website.

## **SUPERVISION ARRANGEMENTS FOR CHILDREN AND OTHER MEMBERS OF GROUPS WHEN NOT INVOLVED IN ACTIVITIES PROVIDED BY LOCKERBROOK**

If you have booked Lockerbrook and outdoor instructor led activities, the responsibility for managing the group during activities resides with the Instructors. Codes of practice will be available for these groups.

When groups are not participating in activities the responsibility for supervision and H&S of the group resides with the group leader.

At weekends there is usually a warden on site to provide a point of contact for the group leaders and to ensure that the group understands our fire safety procedures. The warden will help, but the responsibilities for safety remain with the group throughout their stay.

For groups resident during weekdays there are not usually any Lockerbrook staff on site overnight. We operate an on-call system and visiting staff/leaders are trained in fire alarm operation.

## **TRANSPORT**

Transport is generally only provided for the transportation of a group to and from a licensed activity. Therefore, the provision of transport in this situation is the

responsibility of Lockerbrook. They will be able to provide details of the hire companies used, and confirm that all staff will hold relevant driving license permissions.

## INSURANCE ARRANGEMENTS

Lockerbrook Residential Activity Centre is owned by Woodcraft Folk. Woodcraft Folk is a registered charity in England & Wales (1148195) and in Scotland (SC039791) and a Limited Company, registered in England & Wales, Company No. 8133727, registered office: Holyoake House, Hanover Street, Manchester, M60 0AS.

Woodcraft Folk's activities are covered by employers' liability and public liability insurance, providing that minimum expectations in our policies and procedures are adhered to. ## FIRE PROTECTION

Lockerbrook is not required to hold a Fire Certificate however we take fire safety very seriously and we are subject to periodic inspections by fire officers.

Lockerbrook complies fully with the Regulatory Reform Fire Safety Order, a full fire risk assessment has been completed.

All groups are given a fire safety briefing on arrival at the centre. Fire drills are not routinely offered to groups but can be organised on request.

## SITE SECURITY ARRANGEMENTS

Appropriate security arrangements are in place that can prevent unauthorised persons entering the accommodation. Specifically all buildings are secure and the visiting group have a set of keys enabling them to lock up.

The security of residential, catering and social facilities let to the group as part of their booking is the responsibility of the group leaders who are provided with keys to secure and control all buildings.

## CATERING AND FOOD SERVICE

Lockerbrook may provide a catered service to visiting groups. We have appropriate food safety policies which include ensuring food safety from delivery to service.

All staff involved in food preparation and service are appropriately trained and supervised. We follow guidance from the Food Standards Agency “Safer food better business” and comply with the requirements of this guidance.

Lockerbrook currently holds a food hygiene rating of 5 (the best rating achievable).

## ACCOMMODATION

Our main accommodation is in bunk beds in 7 rooms (2x2, 2x2 interlinked, 1x12, 1x10 and 1x6) and can accommodate separate male and female accommodation if required and separate child and leader accommodation, enabling leaders to sleep separately but close to their group. Separate washing facilities are available.

We can also accommodate up to 6 persons in 3 additional twin rooms in the other buildings on site.

Group leaders are advised to plan accommodation in advance to ensure that the group gender mix and leader/participant mix can be accommodated.
